| Erforderliche Unterlagen | <ul> <li>Completed business registration form</li> <li>Proof of identity (e.g.: identity card or passport).</li> <li>in the case of electronic business registration, other<br/>means of identification are also possible (e.g. electronic<br/>ID card, De-Mail, PIN/TAN procedure).</li> <li>Notarized articles of association or excerpt from the<br/>commercial register, consent of the shareholders (in<br/>the case of legal entities or partnerships)</li> <li>Declaration of consent of shareholders</li> <li>Supplementary sheet for authorized representatives</li> </ul> |
| Voraussetzungen          | <ul> <li>You want to operate a trade. Traders are natural persons or legal entities (stock corporation, limited liability company, registered cooperative or registered association, partnership limited by shares). The following are subject to notification:</li> <li>Sole traders the sole trader,</li> <li>partnerships (e.g. OHG, GbR) the managing partners,</li> <li>KG every personally liable partner, the limited partners of a KG only if they have management authority.</li> <li>corporations (e.g. GmbH, AG) the legal representative</li> </ul>                     |

| Verfahrensablauf         | You must register the start of a standing trade with the<br>competent office. The same applies to the operation of<br>a branch office or a dependent branch.<br>Some business activities require a permit. Others are<br>subject to supervision. Additional requirements apply<br>to them.<br>Find out at an early stage what personal, financial and<br>professional requirements you must meet in order to<br>be able to operate in these trades.<br>You can register your trade in person, in writing or   |

|                                 | If you as a trader do not register the trade yourself, but<br>as a managing partner or legal representative, you<br>need a written power of attorney.  |
|                                 | If you register your business in writing or electronically,<br>you will receive confirmation of your business<br>registration (the so-called "Gewerbeschein") within 3<br>days, provided you have filled out the registration form<br>completely and correctly. If you appear in person, you<br>will receive the confirmation directly at the time of<br>registration. |
|                                 | The responsible office will forward the trade<br>registration to other offices such as the tax office, the<br>Chamber of Crafts or the Chamber of Industry and<br>Commerce, the registration court and the employers'<br>liability insurance association.  |
|                                 | If a permit is also required for your trade (e.g. guarding<br>trade, operation of a restaurant) and this is not<br>available, the competent office can prohibit the<br>continuation of the business.   |
|                                 | The procedure can be handled by a single point of contact.   |

|                                 | A trade is any activity that is not socially unvaluable, is intended to generate profit, is intended to be   |

|               | permanent, and is carried out independently in one's<br>own name and for one's own account. It does not<br>matter whether a profit is actually made.  |
|               | In particular, socially unvaluable activities (e.g.<br>clairvoyance), liberal professions (such as doctors,<br>lawyers or tax consultants) or other activities that<br>require a university degree are not considered trades.<br>Nor are primary production (e.g. agriculture and<br>forestry), scientific management consulting or the<br>management of one's own assets (e.g. an apartment<br>building) as well as generally prohibited or socially<br>unvaluable activities (e.g. illegal gambling).                         |
