Teaser	If you want to transport a load with a particularly large vehicle on public roads, or if the load exceeds legal dimensions, you must apply for a permit.
Volltext	Large and heavy transports are vehicles or their loads that exceed the legally prescribed dimensions and weights. You need a permit and/or an exemption to transport vehicles and trains on public roads if • the load or • the dimensions, • the axle load or • the total weight exceed the limits generally permitted by law.
Erforderliche Unterlagen	RGST 2013 form "Application and notice for the performance of large and/or heavy transport on the carriage of cargoes with excessive dimensions and/or weights". The written application should include: • Period of validity • exact route

- dimensions, axle load and total weight information
- address of the applicant
- written disclaimer
- Exemption according to § 70 StVZO, if not only the load deviates from the permitted dimensions, but also a special vehicle is used, which already unloaded does not comply with the StVZO

Depending on the application, further documents are required. For more details, please contact the responsible road traffic authority.

Voraussetzungen

- Transport by rail or water must not be an option for the requested transport.
- Suitable roads must be available.
- You must be transporting an indivisible load. Special provisions apply in the case of multiple parts.

Verfahrensablauf

You can apply for a permit for large and heavy goods transport in writing or online.

If you wish to submit the application in writing:

- Fill out the RGST 2013 form "Application and Notice to Perform Bulk and/or Heavy Transport of Cargoes of Excessive Dimensions and/or Weights."
- If necessary, the authority may hear you for further information.
- The competent authority will examine your application and decide whether the permit can be granted.
- Under certain circumstances, the permit may be granted subject to conditions.
- After the review has been completed, you will

receive the permit or the rejection as well as the fee notice in writing.

If you wish to submit the application online:

- You submit the application and all required documents via the online portal "VEMAGS".
- If necessary, the authority may hear you for further information.
- The competent authority will review your application and decide whether the permit can be granted.
- Under certain circumstances, the permit may be granted subject to conditions.
- Once the review has been completed, you will receive the permit or the rejection as well as the fee notice online via the portal.

Action before the Administrative Court

Kurztext

- Permit for large and heavy cargo transport Issuance
 - in case of exceeding the generally legally allowed dimensions and/or weights of the load or the vehicle
 - when transporting on public roads
 - issuance of the permit is subject to a fee
 - responsible: road traffic authority in whose district the transport starts or the applicant's registered office is located
 - in the case of foreign companies, the local administrative authority responsible for crossing the border
