Teaser	As a dog owner, you are obliged to register your dog in your municipality of residence. The dog tax is based on the registration.
Volltext	Every dog owner is obliged to register their dog. The obligation to register is regulated in detail in the respective municipal statutes, as is the assessment of dog tax. The obligation to register the dog is necessary, among other things • for dogs older than three months. They must be identified by a transponder with an identification number • when acquiring a new dog or moving in with a dog • when caring for or keeping a dog for a period of time as specified in the local dog tax statutes Please note that more differentiated and supplementary regulations apply to the keeping of so-called dangerous dogs.
Erforderliche Unterlagen	When registering in person, a current identity card or confirmation of registration must be presented. The registration form is also regularly made available for download on the municipality's website.

Hinweise	In addition, every dog owner is obliged to keep their dog on a lead on public roads within a town or in areas that cannot be seen. Outside a place, they must be kept on a lead immediately if other people approach or become visible. Violations of the state law on dangerous dogs (LHundeG) can be punished with a fine of up to ten thousand euros. In addition, violations of the municipal bylaws can also be punished.
