Teaser	Would you like to keep a dangerous dog? Then you need a permit and must meet certain requirements.
Volltext	You need a permit to keep a dangerous dog. By law, dogs of the following breeds, including dogs descended from these breeds, are considered dangerous dogs: • American Staffordshire Terrier, • Staffordshire Bull Terrier, • Pit Bull Terrier. In addition, dogs are considered dangerous if they exhibit increased aggression or have already become conspicuous for biting.
Erforderliche Unterlagen	In addition to the application form, the following documents must be submitted:
Voraussetzungen	As part of this permit procedure, in addition to the required expertise and reliability of the owner, a legitimate interest in keeping a dangerous dog must also be proven. In addition, you must be 18 years of age or older. As the owner of a dangerous dog, you must take out and maintain liability insurance to cover personal injury and property damage caused by the dog with a

	minimum sum insured of EUR 500,000 for personal injury and EUR 250,000 for other damage. Dangerous dogs must be permanently and unmistakably marked with an electronically readable chip in such a way that their identity and dangerousness can be established. Proof of identification must be provided in the form of a veterinary certificate.

Hinweise	The import or movement of dangerous dogs into Germany is regulated by the Act on the Restriction of the Movement or Import of Dangerous Dogs into Germany. Rechtsbehelf	
Kurztext	A permit is required to keep and lead a dangerous dog. Breeding, reproducing and trading in dangerous dogs is prohibited. There are special prohibitions and requirements for handling dangerous dogs.
Ansprechpunkt	The local authority responsible for providing further information and issuing a permit to keep a dangerous dog is the municipal administration of the independent municipality, the association municipality administration and, in independent and large cities, the city administration as the local regulatory authority.
