Voraussetzungen	<ul style="list-style-type: none"> • the applicant is legally established in the home country for the purpose of carrying out comparable activities in a member state of the EU, the EEA or Switzerland. • The exercise of the professional activity in question is linked to a specific professional qualification (regulated) or there is no regulation of access to the profession, but you have completed state-regulated and thus regulated training.

Verfahrensablauf	<p>The craft may be practiced immediately after the notification.</p> <p>**Exceptions**</p> <p>The professions</p> <ul style="list-style-type: none"> • Chimney sweep • Optician • Hearing care professional • Orthopaedic technician • Orthopaedic surgeon • Dental technician <p>may not be exercised until the applicant has received from the competent authority:</p> <ul style="list-style-type: none"> • confirmation that the professional qualification is sufficient, or • Notification that the professional qualification will not be examined. <p>In the event of a lack of qualification identified during a re-examination, the applicant shall be given the opportunity to take an aptitude test within one month.</p>
