Erforderliche Unterlagen	<ul style="list-style-type: none"> • Passport photo • Curriculum vitae with detailed personal details and professional career • Certificate from a German university, the last service authority or the parliamentary group executive committee on the type and duration of the activity (or teaching activity as a professor) in the field of taxes administered by the federal or state tax authorities. The certificate must contain information on: the period of employment (start/end of employment), the type of employment relationship (e.g. employee, civil servant), working time (number of hours per week), the nature and extent of the activity in the field of taxes administered by the federal or state tax authorities, periods of career break of non-temporary duration (e.g. parental leave/parental leave, leave of absence, military or civilian service, longer periods of illness)
