This means that the Youth Welfare Office can and may inform these persons about the legal issues of a right of access. The same group of persons is also entitled to assistance in exercising rights of access. This claim goes beyond legal advice. The Youth Welfare Office can, for example, write letters and conduct mediating discussions. Depending on the circumstances of the individual case, it may also be that such further assistance is not possible.
