Volltext	Recognised mine surveyors shall manufacture and reproduce the cracks prescribed for underground exploration or extraction operations. For other companies, other documents required by the Federal Mining Act, such as cracks, maps and plans, can also be prepared and added by other persons. These other persons must also be recognized. Recognition must be applied for separately for each establishment for which documents are to be drawn up.
