Hinweise	• As a rule, personal reliability is checked by consulting the police certificate of good conduct in accordance with Section 30 (5) of the Federal Central Criminal Register Act and information from the Central Trade Register in accordance with Section 150 (1) of the Trade Regulation Act. The certificate is limited to the information contained therein. • If there are no findings, this shall be certified. • Otherwise, the relevant entries will be certified on request. This makes the legal nature of the certificate clear. • It is not an administrative act, but an instrument of knowledge transfer and serves primarily as access to knowledge.
Rechtsbehelf	If the competent catering authority refuses to certify the findings from the background check, you can file a complaint with the competent local administrative court.
