| Verfahrensablauf             | <p>The application must be submitted in writing to the competent body. This can also be done informally. However, uniform federal forms must be used for the information required to establish the claim.</p>   |

| Frist                        | <p>Support is granted at the earliest from the beginning of the month in which the training begins, but only after an application has also been submitted. Due to the more complex processing of applications for funding abroad, it is advisable to submit an application at least six months before the planned stay abroad.</p>  |

| Hinweise                     | <p>If necessary, the higher funding rates for training abroad can lead to the fact that trainees who are in Germany in particular can be supported. do not receive any support because of the level of income of the parents. Thus, demonstrably necessary tuition fees are covered for a period of up to one year and up to a maximum limit of 4,600 euros. Supplements for travel to the place of training, health insurance and, if necessary, (depending on the destination country) for higher living costs are also possible.</p> |
| Rechtsbehelf                 | Action, without prior opposition proceedings.   |
