<p>Eligible areas are formally defined redevelopment areas, especially in districts with special development needs, areas in which preparatory investigations have been initiated in accordance with Section 141 of the Building Code, conservation areas in accordance with Section 172 (1) sentence 1 no. 1 of the Building Code, previous accommodation areas for the homeless and areas with a municipal housing supply concept or an urban development concept.</p> <p>Eligible for funding are replacement construction measures in connection with the demolition or partial demolition of uneconomical rental residential buildings in areas with a housing supply concept.
