	<ul> <li>electronic proof of identity (eID function) e.g. for identification on the Internet or as proof of age at cigarette vending machines</li> <li>electronic signature is equivalent to the normal signature and allows the digital signing of digital documents, e.g. in the context of administrative procedures</li> <li>two digital fingerprints Only the authorities authorised by the state to do so have access to this biometric area, e.g. officials at border controls.</li> <li>Biometric data cannot be accessed as part of the electronic proof of identity</li> </ul>
