Teaser	Do you have a foreign professional qualification as an educator? In order for you to be able to work in the profession in Germany, you need recognition of your professional qualification.
Volltext	If you want to work as an educator in Germany, you must apply for the equivalence of your training with the local training "state-recognized educator".
Begriffe im Kontext	
Bearbeitungsdauer	The processing time is generally up to 3 months, provided that the application documents are complete. In individual cases, an extension may be necessary. The deadline for submitting the application begins with the confirmation from the competent authority that the required documents are complete.
Fristen	There are no deadlines on the part of the applicants.

Kurztext	Foreign professional qualification Recognition as an educator Even if you have obtained a degree abroad, you can apply for the right to use the professional title "state-recognized

educator" in Germany.
