Teaser	If you have a foreign professional qualification as a social pedagogical assistant, you need to have your professional qualification recognized so that you can work in this profession in Germany.
Volltext	If you want to work as a social pedagogical assistant in Germany, the equivalence of your training with the German training "Staatlich geprüfte Sozialpädagogische Assistentin/Staatlich geprüfter Sozialpädagogischer Assistent" must be established. This is done by the competent authority.

Bearbeitungsdauer	The processing time is generally up to 3 months, provided that the application documents are complete. An extension may be necessary in individual cases. The deadline for submitting the application begins when the responsible office confirms that the required documents are complete.
Fristen	Applicants do not have to observe any deadlines.
