### Volltext

Upon request, compulsory schooling may be suspended:

- \* to attend a language course if you do not have sufficient knowledge of German,
- \* to raise children after the expiry of the statutory maternity protection periods for school-age mothers,
- \* to attend a special extracurricular course of education (e.g. early attendance at a university with a special one-sided talent; not for an internship).

According to the law, the obligation to attend a vocational school is suspended:

- \* for civil servants in the preparatory service as well as for new entrants,
- \* for school-age persons who attend schools for health professions other than medical professions, provided that these schools are not included in the scope of the Lower Saxony School Act,
- \* for school-age persons who are completing a voluntary social or ecological year in accordance with the relevant provisions,
- \* for school-age persons who belong to the Bundeswehr as soldiers or who are doing civilian service.
