Teaser	The operation of a prostitution vehicle requires a permit.
Volltext	<p>Permission to operate a prostitution vehicle must be applied for from the competent authority.</p> <p>§ Section 12 (4) of the Prostitution Protection Act (ProstSchG): The operation of a prostitution vehicle requires a permit from the competent authority. The permit is only issued for a limited period of time. The permit can be extended upon application.</p> <p>§ Section 12 (4) of the Prostitution Protection Act (ProstSchG): Permission to operate a prostitution vehicle is granted for a specific vehicle with specific equipment.</p> <p>If the requirements are met, there is a legal entitlement to the granting of a permit to operate a prostitution vehicle.</p>
Erforderliche Unterlagen	<p>For a permit in accordance with Section 12 (4) of the Prostitute Protection Act, the following documents must be attached to the application in accordance with Section 12 (5) of the Prostitute Protection Act:</p> <ol style="list-style-type: none"> 1. the operating concept, 2. the data on the vehicle; 3. the other documents and information required to prove that the licensing requirements have been met,

	<p>and</p> <p>4. the name, date of birth and address of the person for whom the permit is being applied for or, in the case of a legal entity or association of persons, their company name, address, number of the register sheet in the commercial register and its registered office.</p>
Voraussetzungen	<p>Legal capacity of the applicant. In accordance with Sections 14 and 15 ProstSchG, the applicant or the person designated as deputy or management must possess the required reliability. As a rule, the required reliability is not given if the person fulfills a characteristic listed in Section 15 (1) ProstSchG. Pursuant to Section 16(1) ProstSchG, the main features of the operation of a prostitution vehicle and the precautions taken to comply with the obligations under this Act must be described in the operating concept. § Section 16(2) ProstSchG lists the essential aspects that must be set out in the operating concept.</p>
Kosten	<p>Cost framework: Administrative fee EUR 500 - 4000 Euro Service expenses, if applicable</p> <p>The costs are charged according to time spent; however, they amount to at least EUR 300.</p>
Verfahrensablauf	<p>The granting of a permit requires an application:</p> <ul style="list-style-type: none"> • Application to the competent authority using the prescribed forms and enclosing the required documents. • The documents submitted will be checked for completeness and conclusiveness. • If necessary, additional documents will be requested. • If necessary, an on-site visit will be arranged. • A personal meeting is regularly arranged. • If all requirements are met, the permit will be issued. <p>The applicant receives the permit notification.</p> <p>Otherwise, a rejection notice will be issued.</p>
Bearbeitungsdauer	<p>Depending on the amount of work involved in the examination (a few days to a few weeks after submission of all documents)</p>
