Teaser	As a person established abroad, you must report the first provision of your service under the designation "engineer" in Lower Saxony to the Lower Saxony Chamber of Engineers.
Volltext	The use of the professional title "engineer" is protected in Lower Saxony. If you have neither a place of residence nor a professional establishment in Germany and would like to work temporarily and occasionally under the professional title "engineer" in Lower Saxony for the first time, you must report this activity.
Erforderliche Unterlagen	 Proof of a university degree Certificate of establishment as an engineer and non-prohibition of practising the profession Proof of professional practice of at least one year, if profession is not regulated in the place of establishment
Voraussetzungen	 Proof of professional qualification Certificate of establishment as an engineer and non-prohibition of practising the profession Proof of professional practice of at least one year, if profession is not regulated in the place of establishment the reliability required for the profession of engineer

Hinweise	 The notification necessarily entails entry in the register of foreign engineers. If one year has passed since the last notification and the service provider still intends to provide services in Lower Saxony and to use the professional title "engineer", he or she must notify the Chamber of Engineers. If the situation certified in the documents submitted so far has changed significantly, the service provider must report this by submitting the relevant documents.
