This recognition is then valid nationwide. The procedure to be followed depends on the law of the federal state in which recognition is applied for. If this state does not have its own recognition procedure under state law, it is governed by the law of the state in which the procedure is carried out. After completion of the procedure you will receive a decision in written form.
