Teaser	If you start a business, participate in a business or become self-employed, you must notify the tax office.
Volltext	Companies and the self-employed also have to take care of the tax during the start-up phase. In order for the tax office to be able to correctly classify you for tax purposes, it needs certain information about your company or self-employment. This information must be provided in the "Tax Registration Questionnaire". You must complete and submit this questionnaire online via Mein ELSTER (www.elster.de) or via commercial tax software within one month without
	<ul> <li>individual request from your local tax office.</li> <li>For companies/self-employed persons, partnerships and corporations (also under foreign law) there is a legal obligation to submit the questionnaire for tax registration electronically.</li> <li>With the help of this questionnaire, the tax office determines, among other things,</li> </ul>
	<ul> <li>what kind of taxes you have to pay,</li> <li>when you have to pay,</li> <li>how much you can expect to pay.</li> </ul>
	questionnaire forms the basis for all correspondence with the tax office relating to your company or your self-employment.

	Even if you want to work part-time, you must fill out the questionnaire for tax registration.

• Incorporation of a corporation under foreign law

Make your tax registration with Mein ELSTER (www.elster.de) online:

• Log in to www.elster.de with your ELSTER user account. Note: If you do not yet have an ELSTER user account, you must first register.To submit the questionnaires for tax registration, registration with an e-mail address is sufficient. After obtaining your tax number, you can then upgrade the user account to a full-fledged user account.Information about registration can be found in the help of Mein ELSTER. This is already on the home page (www.elster.de) in the header. You can also watch the video "Registration with My ELSTER" here .

• Then, under the "Forms & Services" tab, select the options "All forms" and "Tax registration questionnaire". Then click on the tax registration questionnaire relevant to your business or self-employment.

• Navigate through the menu of the form and fill in all the necessary information. If necessary, upload the required documents. Once everything has been recorded, you can use the "Check" tab to check the information for discrepancies. If everything is correct, submit the questionnaire. You will then receive a shipping confirmation.Note: If you need help filling it out, please contact the tax office responsible for the operation.

• The tax office will check your information. If necessary, you will be asked by your tax office to submit documents at a later date.

• You will then be informed of your tax number in writing.

Make a tax declaration in writing:

• You can only make the tax declaration in writing if there is no obligation to submit it electronically.

• To do this, download the respective questionnaire for tax registration on the website of the Federal Tax Administration.

• Fill out the questionnaire completely. Use the questionnaire to check whether the tax office needs

	<ul> <li>any further documents from you.</li> <li>Send the questionnaire and any documents to your tax office. The tax office will check your information. If necessary, you will be asked by your tax office to submit documents at a later date.</li> <li>You will then be informed of your tax number in writing.</li> </ul>
Bearbeitungsdauer	The processing time varies depending on the responsible tax office.
Frist	• Tax registration: Usually within one month of starting the activity. Note: In some cases, there are other deadlines, for example when setting up a company abroad.

	documents), you will receive a notification of your new tax number. This communication is not an administrative act. Therefore, there is no right of appeal against the notification of the tax number.
Kurztext	<ul> <li>Registering a company or self-employed activity for tax</li> <li>a tax registration with the tax office is required for: taking up a commercial, self-employed (freelance) or agricultural or forestry activity, Establishment of a corporation, corporation (also under foreign law), a partnership/community or an association, or Participation in a partnership and even in the case of a part-time job</li> <li>Registration takes place via the questionnaire for tax registration and either: if there is an electronic submission obligation, online via Mein ELSTER (www.elster.de) or via commercial tax software, or in writing by downloading the questionnaire in the form management system of the Federal Tax Administration (only possible if there is no electronic submission obligation)</li> <li>the questionnaire is used for the correct tax registration of the company/activity</li> <li>Observe the electronic submission obligation</li> <li>Submission within one month of admission or incorporation</li> <li>there are no costs</li> <li>Responsible: Tax Office</li> </ul>
