Volltext	If you want to trade in poultry, hatching eggs or day-old chicks within the Community, you need a licence.
Erforderliche Unterlagen	Please ask the competent authority what evidence and documents you need to provide.
Voraussetzungen	Specified requirements for the establishment and functioning of the company must be complied with, and an approved occupational health control programme with regard to certain diseases must be carried out. Farms are only allowed to keep poultry for approval. In addition, the establishments are subject to regular official health checks. For more information on the requirements for
