Volltext	In Lower Saxony, dog owners must have the necessary expertise to keep a dog. Upon request, this must be proven to the municipality by successfully passing a theoretical and a practical competence examination. If you, as an examiner, want to carry out and accept the competence test for dog owners, you must be recognized by the competent authority (district or independent city). This recognition must take place before the start of the activity. For recognition as an examiner, you must prove the necessary knowledge and skills.
