	<ul> <li>Children, adolescents or young adults who live in a foster family or in an inpatient child and youth welfare facility ("children's home").</li> <li>Children and young people who have been (temporarily) taken into care by the youth welfare office,</li> <li>young people who are living in a socio-educationally accompanied form of accommodation while participating in school or vocational training measures or during vocational integration .</li> <li>Mothers or fathers caring alone for a child under six years of age and living with the child in a shared mother/father/child living arrangement.</li> <li>Children living with their mother or father in a shared living arrangement for mothers/fathers and children.</li> </ul>

	<ul> <li>Important:</li> <li>Health assistance is only granted if there is no other health insurance cover or if this does not fully cover the necessary needs.</li> <li>The legal guardians or the child or the adolescent or the young adult have a claim.</li> </ul>
Kosten	There are no fees.
Verfahrensablauf	<ul> <li>The competent youth welfare office checks whether health insurance cover exists elsewhere, for example via family insurance or voluntary continued insurance.</li> <li>If there is no priority option for health care or health insurance, the youth welfare office ensures health care (for example by registering with a statutory health insurance fund).</li> </ul>
