Volltext	<p>If you are prevented from practising your profession as a tax advisor or tax representative for more than one month, you must appoint a general representative.</p> <p>At your request, the competent Chamber of Tax Consultants will appoint the general representative for you. The competent Chamber of Tax Advisors may arrange for the appointment of a general representative ex officio if you have failed to appoint a general representative or to request the appointment of a general representative. The representative must be a tax advisor or tax agent.</p>

Voraussetzungen	You are a tax advisor or tax representative.
