With this application you can have the equivalence of a professional qualification acquired abroad with a profession in the judiciary in Lower Saxony determined. This does not apply to the recognition of fully legal professions. Voraussetzungen	<p>There are two basic requirements for submitting an application:</p> <ul style="list-style-type: none"> <li>• You have completed training abroad. You can provide documentary evidence of this training.</li> <li>• You want to work in the judicial sector in Lower Saxony.</li> </ul>
