Teaser	A certificate from the youth welfare office can serve as proof of parental custody
Volltext	A mother can obtain a certificate stating that she is the holder of parental custody of her child and to what extent. The prerequisite is that the mother is not married to the child's father. The information is issued by the local youth welfare office. A father cannot obtain such a certificate.
Erforderliche Unterlagen	Information on the date and place of birth as well as the name of the child at the time of the certification of its birth is required. It may be necessary to submit proof of the mother's identity (e.g. identity card). We recommend asking the responsible youth welfare office about the required documents.
Voraussetzungen	The mother can apply for written information from the custody register. The father of a child cannot apply for information from the custody register. If the child's parents are married, no written information will be provided from the custody register.
Kosten	There are no fees.
Verfahrensablauf	Application by the mother.

	A special form of application is not required
Bearbeitungsdauer	The processing time depends on the respective workload of the youth welfare office. If the custody register is not kept at the youth welfare office responsible for the mother's place of residence, a longer processing time is to be expected.

Hinweise	A court decision can also be submitted as proof of parental custody.

Kurztext	A mother who is not married to the child's father can obtain a certificate stating that she has parental custody of her child.
Ansprechpunkt	As a rule, the youth welfare office in whose catchment area the mother lives is responsible.
