- b) to refresh and further develop the skills and competences that constitute the necessary personal qualification pursuant to Section 1 (1) No. 4,
3. to inform the competent body if a prerequisite for recognition no longer exists, and
4. to prove to the competent body on request that

- b) the obligations under numbers 1 and 2 are fulfilled.
