Teaser	The certificate of no impediment to marriage is issued if it is required for the marriage abroad.
Volltext	If they wish to marry abroad, there may be a legal requirement in the intended state of marriage that requires the submission of such a certificate. The responsibility for issuing a certificate of no impediment to marriage for this group of persons (German citizens without domicile or habitual residence in Germany who have never or only temporarily resided in Germany) is located at the Registry Office I in Berlin.
Erforderliche Unterlagen	The requirements, type and format of the evidence to be provided and the examination of the marriage requirements are governed by German law.

	Public documents must be used to prove: • civil status, • domicile, habitual residence, • nationality, • and, if applicable, the last marriages and/or civil partnerships and their dissolution.
Voraussetzungen	• The person must have German citizenship. • They may not have their domicile or habitual residence in Germany. He or she must never have been in Germany or only temporarily. • The intended marriage should take place abroad. • According to German law, there must be no obstacle to the intended marriage.
Kosten	Costs may be incurred for the issuance of a certificate of no impediment. Please contact the registry office I Berlin.
Verfahrensablauf	The issuance of a certificate of no impediment to marriage is applied for at the responsible registry office I in Berlin. If the examination shows that there is no obstacle to marriage under German law and the necessary information on the person of both parties to the marriage has been provided, the registry office will issue the certificate of no impediment to marriage applied for.
Bearbeitungsdauer	Depending on the individual case
Frist	Once issued, the certificate of no impediment to marriage is valid for six months.
