Teaser	If your existence is at risk as a result of a loss of earnings in accordance with Section 56 (1) or (1a) IfSG, you can be reimbursed for additional expenses to a certain extent upon application.
Volltext	<p>The Infection Protection Act (IfSG) protects the population in Germany. It also provides financial compensation for people affected by the protective measures.</p> <p>If you are quarantined at home or banned from working as a result of an official measure on the basis of the Infection Protection Act and suffer a loss of earnings as a result, you are generally entitled to compensation for the loss of earnings incurred.</p> <p>In the event of a threat to their existence, the additional expenses incurred during the loss of earnings may also be reimbursed to an appropriate extent by the competent authority upon application.</p> <p>Payment and application shall be made in writing to</p>

Voraussetzungen	<ul style="list-style-type: none"> • There was a quarantine according to § 30 IfSG or a ban on activity according to § 31 IfSG. • There was no way to compensate for the loss of earnings with any other reasonable activity. • The livelihood of those affected is endangered and additional expenses have been incurred. • The application for compensation must be submitted within 2 years from the start of the ban on activity or the end of quarantine. • There was no illness or inability to work.

Verfahrensablauf	<p>The application must be submitted in writing to the competent authority.</p> <p>After the claim has been examined by the authority, a corresponding decision will be issued.</p>
Bearbeitungsdauer	Applications will be processed in the order in which they are received.
Frist	<p>2 Jahr(e)</p> <p>The one-year period depends on the period of your segregation or prohibition of activity, or the segregation or prohibition of activity of your employees. After the deadline has expired, you are no longer entitled to compensation for loss of earnings.</p>
