Teaser	If you are an authorized mudflat guide and wish to conduct mudflat tours on additional areas or routes, you will need an extension to your existing permit.
Volltext	You need a permit if you want to conduct guided tours on tidal flats in the Lower Saxony Wadden Sea. The permit requirement is intended to ensure that tidal flat guides have the necessary knowledge and skills to conduct tidal flat tours safely and in accordance with nature conservation regulations. This applies in particular to comprehensive local knowledge of the relevant routes and mudflat areas, the correct planning of a walk to avoid dangers and appropriate behavior in dangerous situations. The permit relates to defined mudflat areas or mudflat routes. If you wish to conduct guided tours on additional areas or routes, you will need an extension to your existing permit. The extension of your permit is issued by the competent authority after your documents have been checked and you have successfully passed an

	interview. Dhe examination interview is limited to local knowledge in relation to the additional areas and routes.
Erforderliche Unterlagen	Proof of participation in at least six tidal flat tours per area/route for which an extension of the permit is sought (in the case of routes between the mainland and an island, participation in at least three tidal flat tours in each direction) within the last two years.
Voraussetzungen	
Kosten	Gebühr: 150€ - 225€ The fee depends on the number of additional areas/routes approved. The stated costs include the administrative fee of EUR 100/150 for participation in the examination interview.
Verfahrensablauf	You inform the competent authority of your interest in taking part in the examination interview, stating the additional wadden areas or wadden stretches. Examination interviews are offered twice a year (usually March/October) and the specific date is usually coordinated with you around three weeks in advance. They take place in Wilhelmshaven. All other required evidence and documents must be submitted before the examination.
Bearbeitungsdauer	1 - 5 Werktag(e) The extension of your permit will be issued after you have successfully passed the examination interview and the evidence and documents are complete.
Frist	6 Jahr(e) The extension to include additional areas or routes is not a new permit with its own period of validity, but takes place within the framework of the existing permit.
