Volltext	If you have taken over grapes, mash, grape must, partially fermented grape must or young wine from a wine-growing business or another business for wine production or for delivery, you must submit a list of suppliers for wine production. You are obliged to report all additions and purchases. You must submit the list of suppliers for the wine production declaration to the competent authority by January 5 of the year following the harvest at the latest. You must submit the list of suppliers for the wine production notification of products from other producers • as a winegrower in Lower Saxony to the (LAVES), • otherwise to your responsible district or independent city.

Kurztext	• List of suppliers for the declaration of wine production from third-party products Receipt • Anyone who processes, uses, sells or transfers wine products, for example wineries or (wine) merchants, is liable to pay the levy • when receiving or taking over grapes, mash, grape must, partially fermented grape must or young wine from winegrowing enterprises or other enterprises for the production of wine products or for unaltered delivery (e.g. grapes, grape must) • In some federal states (e.g. Brandenburg, Rhineland-Palatinate, Lower Saxony), the declaration is submitted together with the wine product declaration or as an annex to the wine product declaration (e.g. Hesse, North Rhine-Westphalia, Saxony-Anhalt) • Form usually available from the competent authority of the respective federal state • Deadline for submission: By January 5 of the year following the harvest • Responsible: Lower Saxony State Office for Consumer Protection and Food Safety (LAVES)
