Teaser	If you already have a weapon possession card (WBK) as a shooting sports club and want to purchase another firearm that requires a permit, you must apply for this.
Volltext	If your shooting club already has a gun ownership card and you want to purchase other firearms requiring a permit in addition to the weapons registered there for the club, you will need a permit to do so. The permit is issued by the competent authority by means of an entry in the firearms possession card (pre-entry). With the pre-entry, you have one year to acquire the registered weapon that requires a permit. In the application for a permit for the further

	acquisition of a firearm, you only need to specify what type of weapon with which caliber you wish to acquire. Further information, such as manufacturer and exact model, is not required for the time being. You do not have to provide this information until you have acquired the weapon and comply with your obligation to report the acquisition of the weapon to the competent authority. The gun dealer must also notify you of the surrender of the weapon. You will need to prove that you can safely store the weapon you intend to acquire.

Hinweise	To be able to fill out the ad faster, you can use the NWR identification numbers (NWR ID): Your personal NWR ID (P or F NWR ID) for your personal information the Permit-NWR-ID for the Weapons Permit (E-NWR-ID) the weapon or weapon part NWR ID (W or T-NWR ID). You can obtain the NWR IDs upon application to the responsible weapons authority.

Licence to acquire and possess weapons and ammunition in the case of an existing WBK for shooting sports clubs (pre-entry)

Acquisition of a weapon requiring a permit must be applied for (entitlement to acquire)

Prior registration entitles the holder to purchase a weapon subject to a permit; without prior registration, arms dealer is not allowed to sell the weapon

For pre-entry indication of type of weapon and caliber is sufficient, not exact model.

Pre-registration is valid for 1 year; Weapon can be purchased within this period

Prerequisite: Weapon possession card (WBK) for clubs

report the acquisition of the weapon to the competent firearms authority within two weeks; Arms dealer also reports acquisition
