Teaser	For a clear assignment of your waste disposal facilities, you must specify the facility numbers issued by the competent authority.
Volltext	In order to enable a clear allocation of your individual business premises for waste disposal, you must use the corresponding official establishment numbers. To do this, use the establishment numbers issued by the competent authority. You enter these official establishment numbers in the forms of the waste documentation procedure, such as waste disposal certificates, consignment bills and transfer bills. The establishment numbers also clearly assign the establishments in other waste law forms such as the waste management company certificate. You can obtain the establishment numbers in Lower Saxony from the Hildesheim Trade Supervisory Office

Kosten	The fixed price is based on the Ordinance on Fees and Expenses for Official Acts and Services.
Verfahrensablauf	• You can apply for a waste disposal number in Lower Saxony via the online service. • The competent authority will first check whether the information provided is complete and plausible and whether the required documents have been enclosed. If necessary, it will request additional information and

Bearbeitungsdauer	7 Werktag(e) The specified processing time may vary if the documents are not complete.
Frist	Official company numbers must be stated in the forms of the waste documentation procedure such as waste disposal certificates, consignment bills and transfer bills. The disposal number must be issued before disposal begins.
