	withdraws or discharges water from a surface water body or withdraws, extracts, discharges or discharges groundwater.
Kosten	The amount of the charge is generally based on the medium from which the water was taken (groundwater or surface water), the amount of water and the rate of charge to be applied in each case.
Verfahrensablauf	Anyone who owes the fee must provide the water authority with the information required to determine the fee by February 15 of the year following the assessment period and provide suitable evidence.
Bearbeitungsdauer	The processing time depends on the quality and scope of the forms and documents submitted.
Frist	Anyone who owes the fee must provide the water authority with the information required to determine the fee by February 15 of the year following the assessment period and provide suitable evidence.

Kurztext	A water abstraction charge may be levied in 13 out of 16 federal states for the abstraction and discharge of water from surface waters, as well as for the abstraction, extraction, underground transportation and discharge of groundwater.
Ansprechpunkt	As a rule, the lower water authorities are responsible for levying the water abstraction charge: districts, independent and large independent cities, Hannover region  in certain cases, the Lower Saxony State Agency for Water Management, Coastal Defence and Nature Conservation (NLWKN) is responsible for levying the water abstraction charge
