Teaser	If you are unable to walk alone in public because of a disability, then you may be exempt from having an ID card.
Volltext	If you cannot move alone in public because of a disability, then you can be exempted from the obligation to have an ID card - that is, from the obligation to have an ID card.  This is the case, for example, if you can no longer leave the house alone because of a disability. You can cancel the exemption at any time. All you need to do is apply for an ID card or a passport.
Erforderliche Unterlagen	<ul> <li>written request</li> <li>as far as available: Your old identity card or passport</li> <li>Proof that you are unable to participate in public life on your own, for example by means of a certificate from your family doctor, hospital, nursing home or care service</li> <li>if you are incapable of acting or giving consent: the original, publicly certified power of attorney</li> <li>in the case of an application by a representative: Proof of power of representation, for example by</li> </ul>

	means of a power of attorney or a guardian's identity card identification document of the representative, for example, identity card or passport
Voraussetzungen	<ul> <li>You must have German citizenship.</li> <li>You must be at least 16 years old.</li> <li>You cannot move alone in public due to a permanent disability.</li> <li>You must be registered with your main residence in your municipality.</li> </ul>
Kosten	There are no costs involved.
Verfahrensablauf	You must apply for exemption from the ID card requirement in writing.
	<ul> <li>You complete the application for exemption from the ID card requirement in full or</li> <li>You or a caregiver sign the application.</li> <li>You attach the necessary documents.</li> <li>You send the application and the documents to the competent ID card authority in your municipality or</li> <li>You go in person to the competent authority.</li> <li>The authority issues you an unlimited certificate stating that you are exempt from the ID card requirement.</li> <li>If you apply in person, you will immediately receive confirmation of the exemption. If you apply in writing, the competent authority will send you the confirmation.</li> </ul>
