This does not apply to private households and small-scale producers who generate no more than two tonnes of hazardous waste per year. Due to the Verification Ordinance, which regulates the verification procedure under waste law, electronic verification and register management is binding for all those affected. In individual cases, the competent authority may grant an exemption from this in whole or in part.
