Verfahrensablauf

If an asylum seeker reports to the border authority, he or she will forward him or her to the nearest initial reception centre, which is the responsibility of the country concerned. However, this does not apply if he meets the conditions for refusing entry, for example because he is entering from a safe third country. If a foreigner only identifies himself or herself as an asylum seeker in Germany, he or she will also first be referred to the nearest initial reception centre. Asylum seekers then submit their asylum application. A data comparison with the Central Register of Foreigners (AZR) is carried out and a residence permit is granted, which grants a temporary right to stay in the Federal Republic of Germany for the purpose of carrying out the asylum procedure. Subsequently, the legally required, non-public hearing of the asylum seeker takes place in accordance with § 25 of the Asylum Procedure Act (AsylVfG) by employees of the competent authority. For this purpose, the asylum seeker must appear in person and explain the reasons for persecution. After that, a decision on the asylum application is made. In principle, the individual fate of the individual is decisive. The decision on the application for asylum shall be taken in writing and shall state the reasons on which it is based. It is served on the asylum seeker with information on the right of appeal.
