## Sachverhalt

- If you use the data for commercial purposes, you must provide it.
- When making the request, you must declare that you will not use the data for advertising or address trading purposes or that the data subject has given his or her consent.
- If you send the request to the competent authority for the purposes of advertising or address trading and the competent authority does not have consent, you must declare to the competent authority that you have your consent.
- The competent authority may require you to provide the consent of the data subject.
- There must be no information block in the population register.

## Kosten

Fees are charged in accordance with Annex 1 to § 1 paragraph 1 of the General Fee Schedule of the State of Lower Saxony (AllGO) in accordance with No. 63.

Fee: at least EUR 9.00

The fee is calculated according to the time spent.

The full administrative fee is also due if there are no registration documents (or no longer) available from the requested person or if no person can be clearly assigned with the information provided by the inquirer or if the content of the information provided is already known.
