Teaser	Would you like to fell a municipally protected tree or carry out pruning? Then you need a corresponding permit.
Volltext	In both public and private areas, the felling or pruning of a tree may constitute a violation of municipal tree protection. The felling or pruning of a municipally protected tree is only permitted under certain circumstances.
Erforderliche Unterlagen	Ask the responsible office which documents you need to submit. As a rule, the exact location and details of the tree itself (species, size of tree) must be included.
Voraussetzungen	Prerequisites for felling or pruning may be • the tree is diseased and has largely lost its ecological functions • further maintenance represents an unreasonable expense for the owner. • there is a danger to people or property

Verfahrensablauf	• As a rule, the application must be submitted in writing to the responsible office. • After the application has been submitted, an on-site inspection may be carried out • You will receive written approval
Bearbeitungsdauer	
Frist	The pruning or felling of trees may only take place after the permit has been issued.
