Kosten	Gebühr: 10€ by lawyer Gebühr: Es fallen keine Kosten an by district court
Verfahrensablauf	If the application has been approved by the Legal Claims Office and the matter cannot be dealt with directly by the district court, a certificate of eligibility for advisory assistance will be issued, with which one can visit a lawyer. If a lawyer is consulted first, he can also subsequently apply for the approval of advisory assistance by the district court.
