Volltext	Flying structures are non-stationary structures that are repeatedly erected and dismantled. Before the first erection and commissioning of flying structures, an execution permit is required. The execution permit is issued for a limited period of time for a maximum of five years in an inspection book.
Erforderliche Unterlagen	• construction and operating specifications, • construction drawings made of paper mounted on fabric or of equivalent material (clear representation of the entire installation, e.g. on a scale of 1 : 100 or 1 : 50), • Individual drawings of the load-bearing components and their connections, e.g. on a scale of 1 : 10 or 1 : 5, • Proof of stability as well as safety verifications of the mechanical parts and electrical systems, • schematics of electrical, hydraulic or pneumatic installations or equipment; • Drawings of the arrangement of the escape routes and their dimensions with mathematical proof for tents with more than 400 visitor places.
