Teaser	Your child will become a schoolchild. More than 1 year before the 1st day of school, the path to get there begins.
Volltext	Primary school in Lower Saxony comprises grades 1 to 4. In primary schools with an entry level, children in the 1st and 2nd grades are taught in multi-year learning groups, which they attend for one to three years. Your child is required to attend school. In Lower Saxony, they are usually enrolled in school if they have reached the age of six by 30 September of each year. This includes children who have their 6th birthday on 1 October.

Children born after 1 October (so-called optional children) can also be registered; there is no special cut-off date here. The school principal decides on admission.

Approximately 15 months before you start school, you will be required to register for

to the primary school responsible for your child. The school authority – i.e. the city or municipality – or the primary school will inform you of the exact registration date in good time. Your place of residence decides which school(s) is responsible for you. Information on this can be obtained from the school authority or a primary school in your area.

In Lower Saxony, all children are medically examined with regard to their state of development and health before starting school as part of the school entrance examination. School-relevant strengths and weaknesses of the child will be determined, you will be advised and, if necessary, support measures will be recommended for your child. Participation in the school entrance examination is compulsory for your child. You will receive an invitation.

Your school-age child may be deferred for one year if, due to his or her level of development, it is to be expected that he or she will not be able to work successfully in the first year of primary school or a special school. It may be obligatory to attend a school kindergarten if this institution exists in the area of the school authority. The decision on the enrolment or deferral of your child is made by the school management after consultation with you as the legal guardian. In primary schools with an entry level, a deferral is to be refrained from.

If your child has their sixth birthday between 2 July and 1 October, you can postpone school attendance for one year by sending a written declaration. This does not have to be justified (flexibilisation of the school enrolment date).

Verfahrensablauf	You must register your child in person at the primary school responsible for you about 15 months before starting school. You will often receive an invitation to attend. Check with the school beforehand what other forms you need besides the birth certificate and vaccination certificate. In addition, your child's school entrance examination will be carried out by the paediatric and adolescent medical service of the health department. You will receive an invitation for this.

Frist	• The registration date will be announced by the school authority in the usual local manner, usually in the period from 1 to 8 December. Experience has shown that this will be in May/June in the year before the child is of school age. • The informal declaration to postpone school attendance by one year must be submitted to the school before the start of the school year in question by 1 May.

Inclusion/need for special educational support: In Lower Saxony, all schools are inclusive schools. They provide all pupils with equal and barrier-free access. Parents of pupils in need of special educational support can decide whether their child should attend a primary school or a special school. Since the primary level of special schools in the focus area of learning has been phased out, all pupils in need of special educational support in the focus area of learning go to primary school. In addition to the primary school, the contact persons are the Regional State Offices for School and Education (RLSB) and the Regional Counselling and Support Centres for Inclusive Schools (RZI).

Language support: Since the 2018/2019 school year, the language development of all children who attend a day-care centre has been observed, documented and promoted in an everyday way by the socio-pedagogical specialists. At the latest at the beginning of the kindergarten year, which immediately precedes compulsory schooling, the child's language competence must be assessed, a developmental discussion must be held with the legal guardians and, if necessary, individual and differentiated language support must be initiated. In the case of children who do not attend a day-care centre, the responsible primary school determines the language skills as part of the school registration process and sets up language support measures for children who do not have sufficient knowledge of German in the school year before they start school. This language support is legally anchored in the Lower Saxony School Act and participation in it is compulsory for the children concerned (early compulsory schooling).

Responsible primary school: If parents wish to attend another primary school for important reasons, an application for exemption must be submitted to the responsible primary school. Kurztext	 Enrolment of a child in primary school Primary school in Lower Saxony comprises grades 1 to 4. Education is compulsory. It begins in the school year in which a child reaches the age of six by 30 September. Parents or guardians register their children in the primary school responsible for them about 15 months before the start of the school year in which the children are of school age. Children born after 1 July can start school one year later at the request of their parents. (Flexibilization of the school enrolment date) Parents or guardians can request that your child born after October 1 be admitted to primary school (can-child). The decision is made by the school management. A school entrance examination will take place. This is organized by the health department. Participation in the school entrance examination is compulsory for the children. The legal guardians will receive an invitation. The responsibility lies with the primary school in whose school catchment district the residence is located.
