Volltext	Children, adolescents and young adults who have no parents or do not receive regular care in their parents' home find a home in youth welfare institutions. The reasons for accommodation in youth welfare institutions vary: • the death of both parents • a child does not receive the necessary care and care from his family • Parents don't feel up to the responsibility of raising a child • Difficulties at school • Behavioural problems • Developmental disorders • Mental disorders / disabilities There is a variety of accommodation options for children, adolescents and young adults, such as residential groups, shift work groups, family-like residential groups, educational centers, individual forms of care, 5-day groups, intensive groups, project centers at home and abroad. The objective of home education is: • Protection (against child endangerment) • Return to family • prepare for education in another family • offer a long-term life form • Preparing for an independent life • Integration assistance for the mentally handicapped • Mother/father/child care • Intensive pedagogical / therapeutic aids
