Teaser	Registration of a new vehicle from an EU country is possible upon application. Approval is granted by the competent licensing authority.
Volltext	Vehicles may only be used on public roads if they are approved for traffic. In the case of a new vehicle with a general type approval or EC type approval, you must apply for the allocation of an official registration number.

	<ul> <li>Day of first commissioning</li> <li>Mileage on the day of delivery</li> <li>Vehicle type, vehicle manufacturer (brand), vehicle type and vehicle identification number</li> <li>Use</li> <li>if represented by a third party: your written power of attorney and your identity document (original); the authorised representative must be able to identify himself with his valid identity card/passport.</li> <li>in the case of admission to minors: the written declaration of consent of the legal guardians and their identity cards (in the original); If applicable, a certificate of sole custody (so-called "negative certificate") for single parents</li> </ul>

Kosten	The fee is levied in accordance with the Schedule of Fees for Road Traffic Measures (GebOSt). Their amount depends on various factors. In individual cases, information can be obtained from the locally competent licensing authority.

Hinweise	Vehicles whose first registration in another EU member state was not more than 6 months ago or whose previous mileage is less than 6,000 km are considered new vehicles according to § 1b UStG.  If there are vehicle tax arrears or if you have arrears of fees and expenses from previous registration procedures, the registration authority will refuse registration until you have paid them.
	If someone registers your vehicle on your behalf, the authorised representative must provide a written power of attorney from you. This must also include a declaration of consent for the licensing authority to

	inform the authorised representative of any arrears of fees and expenses.

Kurztext	<ul> <li>Registration of a new vehicle from an EU country</li> <li>Application is required</li> <li>Authorisation is granted by the competent licensing authority</li> </ul>
Ansprechpunkt	The responsibility lies with the district, the independent city and the municipality, joint municipality and city entrusted with this task.  In this case, the main residence according to the identity card is decisive. In the case of legal entities, this is the registered office of the principal place of business or the seat of the branch.
