Volltext	Anyone wishing to extract mineral resources such as gravel, sand, marl, clay, loam, peat or stone requires a permit from the competent authority if the area to be extracted is larger than 30 m <sup>2</sup> . The permit includes the building permit.
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• The application must be accompanied by: <ul style="list-style-type: none"> <li>• a nature conservation survey of the areas intended for quarrying, including the operational areas and</li> <li>• a professionally prepared plan showing all essential details of the extraction project, in particular <ul style="list-style-type: none"> <li>• the location, surroundings and spatial extent of the quarrying operation</li> <li>• investigations carried out,</li> <li>• the type and method of extraction,</li> <li>• the ancillary facilities,</li> <li>• the use of the areas used for mining and ancillary facilities after mining,</li> <li>• the preparation and utilization of the areas,</li> <li>• where necessary, the compensatory and replacement measures,</li> <li>• the costs of the compensatory and replacement measures,</li> <li>• a schedule for the quarrying and the compensatory and replacement measures.</li> </ul> </li> </ul> </li> </ul>

Frist	The permit expires if mining does not commence within three years of its issue or if mining is interrupted for longer than three years. The period may be extended upon application.

Hinweise	<p>Further details on the approval procedure under nature conservation law can be found in the circular "Mining of mineral resources" (Nds. MBL.
