Teaser	
Volltext	Traffic signs (VZ for short) and traffic facilities are used to regulate traffic. They are ordered by the authorities and are to be observed by the road user on his own responsibility. Traffic signs include traffic signs, road markings, lighting displays, as well as signs from traffic posts. Traffic facilities include barriers, barrier posts, parking meters, parking ticket machines, railings, barriers, guidance devices as well as flashing lights and traffic lights ("traffic lights"). Any installation, modification or removal of traffic signs or traffic facilities requires a traffic authority order from the competent authority.
