	You are free to decide how you use the financial support you receive.
Erforderliche Unterlagen	 Copy of the notice of assessment of the "Bl" markor a valid severely disabled person's pass with the registered "Bl" mark Proof of habitual residence in Lower Saxony Documents that are suitable to substantiate the reason you have given for the benefits applied for If the application cannot or should not be submitted by the applicant him/herself, proof that the applicant is authorized to submit the application (e.g. power of attorney, guardian's certificate)
Voraussetzungen	 You must have been awarded the mark Bl, which stands for blind, by a notice of assessment. You must not be living in an inpatient facility (e.g. nursing home) or in a special form of accommodation for integration assistance.
Kosten	Gebühr: Es fallen keine Kosten an There are no fees.
Verfahrensablauf	 You submit an application to the Lower Saxony State Office for Social Affairs, Youth and Family in Hildesheim for benefits from the State Fund for the Blind. The authority will check your application and contact you if there are any queries or missing documents. Once all the documents have been submitted, the authority will check your entitlement to benefits from the State Fund for the Blind. After the review, you will receive a notice of approval or rejection.
Bearbeitungsdauer	A decision on the application will be made as quickly as possible. The processing time depends, among other things, on the completeness of the information and the submission of the evidence required for processing the application.
Frist	No deadlines need to be observed. However, the application must be closely related to the purpose.
