Handlungsgrundlage	
Teaser	Notifiable slaughterhouses must report their prices for slaughter quantities in the respective categories and commercial classes. The report is made on a weekly basis according to the prescribed model.
Volltext	Market activity in the slaughter cattle sector is subject to strong fluctuations due to the constant change of supply and demand. In addition, there are a large number of suppliers and buyers, which makes it very difficult to have an overview of the market. In order to ensure market transparency, however, there is the instrument of official price quotation. The monitoring is essentially based on the Livestock and Meat Act with the corresponding implementing regulations as well as the Commercial Class Act with the respective regulations for the individual animal species. On the basis of the quotation sheets compiled, the quotation commission determines the price ranges of the respective categories and trading classes for the previous week from Monday to Sunday.
