Volltext	A permit is required for commercial keeping, breeding, display, use of animals and trade in animals. The permit may be granted, insofar as it is necessary for the protection of the animals, subject to time limits, conditions and obligations.
Erforderliche Unterlagen	No documents are required.
Voraussetzungen	• The person responsible for the activity must have the knowledge and skills necessary for the activity by virtue of his or her training or previous or other handling of animals. Proof of this must be provided on request in an expert discussion with the competent authority. • The person responsible for the activity must have the necessary reliability. • The rooms and facilities used for the activity must enable the animals to be fed, cared for and accommodated in accordance with legal requirements.
Kosten	Fees are charged in accordance with the annex to §1 of the Schedule of Fees for Administration in the Field of Consumer Protection and Veterinary Affairs (GOV) in accordance with Section V1.1.8.
