Volltext	A prerequisite for vocational retraining is a training centre suitable for the respective training. Suitability is also fulfilled if training measures are carried out outside the training centre. The type and equipment of the vocational training centre must be suitable (vocational training centre - monitor suitability). The competent body (e.g. the relevant chamber) supervises the implementation of vocational retraining from the beginning of the measure and promotes it by advising the persons involved in the retraining. It must appoint advisers for this purpose. The body responsible for training is responsible for the suitability of the training centre as well as for the elimination of possible complaints. If a defect cannot be remedied, the competent authority under Land law must be informed. On request, trainees, retrainees and other persons are obliged to provide the information necessary for supervision, to submit documents and to permit visits to the training centres. The competent authority works closely with the supervisory authority, in particular in the implementation of the Youth Employment Protection Act.

	In the case of vocational training/retraining in occupations of agriculture and rural housekeeping as well as home economics, the training centre must be recognised by the competent authority under Land law. The Federal Ministry of Food, Agriculture and Consumer Protection and the Federal Ministry of Economics and Technology, in agreement with the Federal Ministry of Education and Research, may, after consulting the Joint Committee of the Federal Institute for Vocational Education and Training, lay down certain minimum requirements for the size, equipment and management status of the training centre by ordinance.
