Volltext	Anyone who has completed training as a veterinarian from a non-EU member state, but does not have a license to practice medicine, and only wants to practice the veterinary profession temporarily, needs a permit. The permit entitles the holder to use the professional title "veterinarian" or "veterinarian". The permit may be limited to certain activities and places of employment. It may only be granted or extended on a revocable basis and only up to a total duration of veterinary activity not exceeding four years. Kurztext	Veterinarians without a licence to practise medicine **from a non-EU Member State** who wish to practise the veterinary profession only temporarily require a licence.
